I further agree that if any damages shall be occasioned or loss occur, by fire or other, to the horses exhibited, or to any vehicle or other article that I may send with such horses, that I will make no claim therefore, and further agree to hold Willowbrooke Farms, owners of the show grounds, officials, member or employees harmless from any claim or demand of whatsoever kind of nature, that may be occasioned by the horse(s), and to repay to this show on demand all damages it may sustain by reason of any claim or demand as aforesaid.
